CONFESSIONS OF A WOMAN OF DISTINCTION

My first confession is that although I have been a



member of AAUW for over fifty years, I knew nothing about the AAUW National Conference for College Women Student Leaders (NCCWSL, pronounced Nic Whistle). I had no memory of the Women of Distinction program, or

that, in fact, NCCWSL had been in existence for thirty-four years. The Women of Distinction program has been in existence for thirty-two years, and AAUW Maryland had been the platinum sponsor for seven years.

My introduction to NCCWSL was in a telephone call telling me that I was the Maryland Woman of Distinction for 2017. Later I learned that the purpose of the conference is to bring women college student leaders together to hear about opportunities to develop leadership skills. Approximately 1000 women students attended the 2017 conference, coming from all parts of the United States. The students stayed in dormitories on the University of Maryland campus. For many of the students, their costs of attendance were paid by donations from individual AAUW branches across the country.

On June 1, 2017, at the student union of the University of Maryland, I was the Maryland woman honored as a woman of distinction, introduced humorously by Margery Sullivan. AAUW had nominated four other women of distinction. As the platinum sponsor, AAUW Maryland names its own woman of distinction. Women previously named as Maryland Women of Distinction include: Jenny Forehand, Janet Crampton, Barbara Fetterhoff, and Dr. Mary Grace Roman. Generous donations from AAUW Maryland members provide the platinum sponsorship cost of \$20,000.

Along with the national nominees, I gave a short speech. My message was "invest in yourself." After the program, over 100 students lined up to meet me and to have their pictures taken. Their message to me was "thank you for what you have done for women."

From the President – Changing the Climate for Women and Girls in Maryland

As summer ends, I am excited to see the commitment of AAUW Maryland members working to change the climate for women and girls in Maryland. In June, we honored Cleopatra Campbell as Maryland's Woman of Distinction at the National Conference for Collegiate Women Student Leaders and joined members from throughout the United States for the National Lobby Day and Convention in Washington, DC. At the July Board meeting, we agreed to build on last year's strategic plan successes with continued emphasis on growing our membership, increasing our visibility in public policy and promoting communications and branch member participation in state activities.

At the July Board meeting, we voted to support two bills sponsored by branches - a bill to extend child support for post-secondary education (Howard County) and the Maryland Patients' Bill of Rights (Kensington-Rockville). We also agreed to work in coalition with the Maryland Legislative Agenda for Women (MLAW) to support \$15 Minimum Wage and Fair Scheduling Coalition.

I encourage all members to attend the October 21 state meeting in Gaithersburg. During the morning

session, we will develop our skills to effectively advocate for these and other issues of concern to Maryland women during the upcoming State General Assembly meeting.

We welcome two fresh faces to the state's leadership team. Caitlin Brauer has been appointed College/University Representative. Caitlin, who now is a member of the Baltimore Branch, was the head basketball coach at Frederick Community College and a member of the Frederick Branch. Toni Ann DeGuzman, who has just completed her 8-month Website Production internship at AAUW National has agreed to be our webmaster and Facebook administrator. During her internship, she worked in Site Resources which deals with over 500 branch websites including the Maryland State and many branch sites. Toni is an undergraduate student at Capitol Technology University (third year) in Laurel, studying Web Development.

On a personal note, I am honored to have been appointed to the AAUW National Board of Directors for a two-year term. I look forward to working with other board members and with Kim Churches and her staff as we continue to grow AAUW.



Marylander Public Policy - AAUW Leading the Way for Gender Equity in Maryland

It has been an eventful summer for AAUW MD advocacy. Members have stormed Capitol Hill and Annapolis in force to promote public policy that advances economic and educational equity for women, girls, and families.

On June 15, AAUW MD members were invited to participate in the AAUW Capitol Hill Lobby Day during AAUW's National Convention. Seventeen members from several branches statewide were part of the AAUW MD delegation. The Maryland congressional delegation--two senators and eight representatives-- received visits from their AAUW constituents. Members advocated for enforcement of civil rights in education and college affordability and were presented with AAUW's new report *Deeper in Debt: Women and Student Loans*. Several AAUW MD members also volunteered with Lobby Corps that day to make sure our members made it to their meetings. Kudos to all who helped make the lobby day a great success.

Individual advocacy for federal legislation does not have to wait for another national convention. I hope all AAUW MD members will consider being a part of the AAUW MD's proud tradition of joining the Lobby <u>Corps</u> which is held every Thursday when Congress is in session. MD volunteers have been a part of Lobby Corp since its inception in 1972. Lobby Corps is critical to our mission because it gives our national membership a voice and a face on Capitol Hill making AAUW a familiar and respected name among members of Congress and their staffs. During the Summer Leadership Conference in July, the AAUW MD Board voted to support state legislation for 2018 that addresses critical needs for women and families. AAUW MD will actively support a bill to extend child support for post-secondary education sponsored by AAUW Howard County, and the Maryland Patients' Bill of Rights sponsored by AAUW Kensington-Rockville. AAUW MD will work closely with Maryland Legislative Agenda for Women (MLAW) to promote these bills and other important legislation during their annual legislative conference and advocacy days in Annapolis.

In August, I joined Howard County branch members in meeting with MD Delegate Kathleen M. Dumais (District 15), Vice Chair of the Judiciary Committee, for a helpful conversation about what it will take to make AAUW MD priorities law. We are grateful for her candid advice and offer to help us meet our objectives.

AAUW MD members are also working closely with MD Attorney General Brian Frosh and his staff on public policy priorities. During a meeting in August, AAUW members met with the Attorney General to discuss enforcing gender equality in colleges and universities, protecting consumers in the healthcare system, and finding ways to make higher education more accessible for all Marylanders. Attorney General Frosh agreed to work with AAUW MD on all of these issues.

We will begin holding statewide public policy calls for branch leadership to strategize and implement

plans to move our public policy program forward. Members can also expect to see e-advocacy from our Action Network on state issues as well as invitations to policy events including the MLAW conference in the fall and receptions and lobby days in Annapolis into the new year. Marylander AAUW Convention 2017

My first AAUW Convention

This year I attended my first AAUW National Convention. I did not know exactly what to expect, so I arrived with an open mind and many hopes. The Renaissance hotel in downtown DC was full of women. I typically attend business conferences where women are in the minority. This was a great change of pace for me.

After getting my badge, I was immediately distracted by the fun items that AAUW and other vendors had for sale. Of course, I picked up a whole packet of stickers to share with my branch. I also chose some nice little inspirational posters to put up in my home office. However, my best acquisition was an AAUWembossed backpack. It has already been with me from Ocean City to England and Scotland and Ireland. I'm glad that the vendors give back to AAUW and other worthy causes. I felt very good about my purchases.

The program on Day 1, Wednesday, was an inspirational briefing to get everyone up to speed for the full court press Lobby Day happening on Thursday. We heard from Anne Hedgepath, acting VP for Government Affairs, about how important citizen lobbying is to the legislative process. We also heard from some fantastic women political leaders who gave us great advice on how to persevere in order to obtain out goals, whether legislative or otherwise. Congresswoman Brenda Lawrence's (D-Michigan) remarks particularly stuck with me. She is fighting every day for all of AAUW's causes and more. With respect to education issues for poor and minority students. She said that private prisons are being built faster than public schools. And there is not enough effort to train young people, women and men, for high tech jobs. This is right up AAUW's allev!

Because of the Lobby Day pre-session, the actual day was a huge success. Various subsets of the Maryland contingent were able to visit both Senators' offices as well as the offices of all eight of Maryland's Representatives. At each visit we were greeted enthusiastically and received excellent, upto- date information on the issues on which the Senators and Representatives were engaged. Personally, I was glad we met with a young, female legislative assistant in Congressman Delaney's office. She seemed very interested in the student debt issue and how it impacts women workers long after they are finished with their education.

On Friday and Saturday I attended the breakout on social media and one on mission-based programming. I learned a lot from the social media session, especially that our branch needs to step our "SM" outreach! We've already updated our Facebook site. Other branches are really active in the SM sphere. Facebook is a great way to get the word out to non-members about AAUW's great programs and mission. The programming session was also incredibly informative. I took away several handouts that make it very easy to pair topics with venues and plan out public engagements in a relatively easy way. Of course, the real key is enticing members and non-members to attend.

I learned that programs need to give folks a chance to make an impact.

One of the best things was being able to hang out with many fellow Maryland members that I don't see very often. We mostly sat together at the plenary sessions and absorbed the information together. The final session, including the transition to the new Board of Directors and a speech from the new CEO, Kim Churches, was very inspiring as well as honest in discussing the challenges that lie ahead for the national organization. I think we all accept that challenge and hope that by the time of the next convention, significant progress will have been made.

AAUW CEO Chats with Sonia Sotomayor at the National Convention Banquet

Associate Justice Sonia Sotomayor was honored on June 16 at the AAUW Convention. Rather than a traditional speech, there was a discussion was a series of questions, most of which Justice Sotomayor answered while walking among the AAUW members at the Convention Banquet. The following summary is based on my notes.

Kim Churches: Tell us about your book

Justice Sotomayor: People tend to like absolutes; clear answers. We don't need judges and lawyers if the law is clear, which it is not. And neither is life. The book idea was prompted by the question of how a happy childhood informed my life, but I didn't have a traditional happy childhood. Becoming an Associate Justice catapulted me into a new universe, removed me from a job and life I enjoyed, and made me world famous. I became scared that I would lose the essence of Sonia. The book started as a way to hold onto myself. I needed to include the good and the bad. The book was my journey to figure out what made Sonia.

KC: Your Mother was widowed at 36 with two children. Do you consider yourself a feminist?

JS: What working woman can't (and working means both inside and outside the house)? You're struggling to achieve equality for all those around you. A woman is taught to work for everyone around her, not for herself.

KC: Has the definition of feminism changed?

JS: I bet it has for you. Women are 50% of your schools, which is a different experience than mine. At Yale, women were less than 20%. It was not your world. You have Title IX. Sports are empowering for women; Title IX was transformational. I watch my niece; they split the check on dates. Pay equality, "That doesn't happen to me," my niece says. But pay differences are still a reality. Things that happened to me will still happen to you. I've been called honey when on the bench. The false sense of comfort is misleading. We do not have full equality. It's too easy to let the superficial convince you we are equal.

KC: How does the Supreme Court of the United States decide cases?

JS: I'll take the 1995 Baseball Strike case as an example. As a justice, you want to bring clarity to unclear issues. Reasonable people have looked at the issue and come to different answers. Social issue cases are the ones people are most interested in. All the justices are good writers – they have to be. In many cases there are arguments on both sides. KC: Social Rights – the Supreme Court is the back stop. How is this true for women?

JS: The Court has never been a leader on women's rights. The leaders have been you. The right to vote was not settled by a court case. It was a political battle. Until 1970, every case the Court decided held against women. In the 1970s, some women's issues were being upheld by the Court. They were argued by Ruth Bader Ginsberg (RBG), then a pioneer with the ACLU Women's Rights Group. It was strategic brilliance - get the Court's attention by bringing cases where men are being treated less well. At that time, women in the military got the child care benefit, but not the men. Women taking care of their parents received a tax benefit, but not men. So it became harder for the Court to rule against women because these cases expanded rights to equal benefits. In the Virginia Military Institute case, RBG established that discrimination on the basis of gender deserved heightened scrutiny. Since that case, the Court has been better. But lobbying and political action are still the leaders in getting the law changed. You cannot get equality via the courts. You have a lot of work to do.

KC: Women in High School and College are concerned [about all kinds of equity]. What advice do you give your niece that we can take home as well? JS: Education is the only path to equality. It opens your mind to possibilities. You can't dream about something you don't know about. You need basic education to open your mind to dream big: awareness of the confidence gap, [career] possibilities, and the price you pay. You are living life. Your child will need to learn to handle competing values, how to balance difference parts of life, and how to compromise. It sounds simple, until someone talks to you about it.

KC: You are involved with the iCivics organization (icivics.org).

JS: Civics has been gone from schools for 35 years. How do we teach our children to be good citizens? Go to icivics.org and play one of their games. You won't get 100%. The best way to teach is via games. It has worked. Seventy million students across the country have participated. The Ford Foundation is underwriting the rewriting of the games so ESL students can play the games. They also have teaching tools for high school teachers. (Side note: Retired Justice Sandra Day O'Conner founded iCivics. She got Justice Sotomayor involved.) I truly believe we don't have a choice to be bystanders. Laws don't just happen. People have to lobby for them. The somebody else is us. Civics is critical. We need it to maintain our republic form of government.

KC: AAUW is non-partisan. ... Tell us about your relationship with Justice Antonin Scalia.

JS: Nino and I were talking one day. He said: "You're a bulldog. ...I like you so much ... tough and in your face." I'm passionate and so was he. It would spill over and make people uncomfortable. We both deeply cared about our system of government, our country, our constitution. We wanted different things, but we both wanted to do the right thing. [Often] we don't listen to people, [to know] what they fear, why they head down a road we don't like. People are no longer meeting in the middle. The answers to our divisions are not easy. We have no choice. We must find solutions that can work for both sides. We must find a way back. For every parent, we need to find a better way.

Summer Leadership Conference

Our exciting summer conference entitled "Actions to Bold Effective Leadership" held on July 25, was hosted by the Frederick Branch. The conference was held at the South End Baptist Church in Frederick with approximately 38 attendees. Conference attendees were welcomed by Jude Olivey, Frederick Branch Secretary and Frederick County Executive Jan Gardner.

Eileen Mention, State President, provided an update on the State Strategic Plan—where we are currently towards the goals we set last summer, and the goals for this year. Details were provided in the electronic communications to all branch leaders.

Six breakout sessions were led by various board members on "What is my role now that I have this job?" Attendees shared recommendations and best practices on how to perform in their roles as fundraisers, membership chair, program chair, public policy chair, treasurer, and president.

Lastly Kimberly Churches, AAUW CEO, held an interactive Town Hall with attendees asking members what challenges we face at the Branch or State level. She provided a brief view of her background and explained how the commitment of AAUW's members drew her to the organization. Kim asked questions such as: Where are our core strengths and Where are we going next?

She provided some insight on her thoughts for AAUW's national leadership focus, emphasizing the need to decide who we are and who we are not. We

need to ensure we have Focus, Relevance, and Impact and scale our initiatives. Kim described her leadership style and philosophy for the organization. She described the current organizational structure at National as being flat and explained plans for better collaboration. She emphasized that she plans to be a transparent CEO. She expressed a desired to change the 'all things to all people' mission mentality to allow for improved focus on how we deliver. She is working on a new strategic plan to involve more members. The intent is to have a national plan with plans that flow down to the branch level, and that is a living breathing document to allow us to remain flexible as an organization.
