Summer Leadership Training

Summer 2015: Cultivating Current and Future Leaders

An inspiring and interesting summer conference planned by Co-Vice Presidents for Programs,

Susan Wierman and Markonette Richardson was held July 25. Hosted by the Easton Branch the conference was held at the beautiful, new campus of Chesapeake College in Wye Mills.

Conference attendees were welcomed by Linda Tebbs, Easton Branch Co- President and the Maryland AAUW Co-Presidents Dorothy Fraquelli and Sandra Smith.

The leadership development part of the program, "Your Opportunity to Grow: Cultivating Leadership and Teamwork," was led by the charming, intelligent Erica Stout, Training and Program Manager of AAUW. A year ago, she offered a most helpful presentation on building membership. This summer, she focused on delegating tasks.



While many AAUW members seek volunteers and helpers often in their various life tasks, her presentation reminded them that they may not think about how to go about it more effectively. She suggested three steps to keep in mind in delegating.

The first step: **Get on the Same Page** includes explaining to a potential helper why the task is important, what successful completion looks like, a time line for completion, and suggestions, perhaps, on how it is to be done.

The second step is **Check In**. Here the task delegator should base the frequency of checking in on the difficulty of the task and the level of skill of the volunteer. And most importantly, the delegator should frame the check-in as a means of support.

The final step is **Debrief and Celebrate**. Here the delegator provides positive, and if needed, corrective feedback, gives recognition, and thanks, and asks for feedback.

Erica Stout presented this information with great visuals, stories, and input from the audience. The formal framework for offering a task to someone is something all delegators can go back to as they identify members to help with the fulfillment of AAUW mission. She reminded us that in order for new members to feel connected, they need to be involved in a task.

After Erica's comments and a delicious lunch, participants joined small groups to discuss Public Policy, Website and Communication Techniques, and Training for Treasurers. Nearly 40 enthusiastic participants caught up on each other's lives, shared effective branch activities, and asked and answered questions about AAUW operations and interests.

Welcome Aboard New Treasurers

Thank you for everything that you are doing to keep accurate financial records for your branch. Here is a brief list that AAUW designed especially for you.

- 1. Know the AAUW national membership types and the different dues, fees, and tax deductibility rates.
 - a. Be aware what membership discount incentives are available for new member recruitment, too.

- b. Add your state and branch dues to determine the total cost of membership.
- c. Please keep in mind that when a new member joins through the **Shape the Future** program, the AAUW-MD dues are **\$10**.
- 2. **Understand the Branch Dues Report Process**. You will submit collected dues as members join and renew others throughout the year, so select a method that best meets your needs.
 - a. Online users prefer the Member Services Database (MSD) for easy online record keeping.
 - b. Others upgrade to the Membership Payment Program (MPP) for renewal invoicing and the allowance of payments by check or credit card.
 - c. Watch the Adobe Connect session that's on the AAUW website with your president and membership chair, so that you all understand the process and can function as a team. It's called: Membership Dues Processing Webinar: Success Made Simple!
- 3. **Complete the Group Tax Exemption annual form** located in the Member Services Database on the AAUW website.
 - a. The Annual Form was activated on July 15th and will close on October 15th.
 - b. Use the form, and choose if you'll be filing the branch and/or state 990-N (e-Postcard) for the year yourself or if you'd like the national office to file on behalf of the branch and/or state.
 - a. **All** AAUW-affiliated entities are required to file 990, 990-N or 990EZ forms each year. Those with annual gross revenue receipts of \$50,000 or less, are required by the IRS to complete form 990-N (e-postcard).
- 4. **Download the Branch and State Finance Tool Kit** and keep it handy for a reference. The Tool Kit covers budgeting, records management, and other important information about taxes and contributions. The link is: http://www.aauw.org/resource/finance-tool-kit/
- 5. **Know the fundraising rules and best practices** by reading Fundraising Policy 501. The suggestions are very helpful, so please share them with for your Fund Raising Chair.
- 6. **Read** Membership Matters when it arrives in your email inbox. These messages are handy to keep you aware of important dates, deadlines, and activities.
- 7. **Contact** to your branch and state membership vice presidents, the finance committee, and AAUW staff, because an effective finance officer relies on a great support team. Please don't hesitate to contact me if I can help.
- 8. Find the AAUW financials in the Annual Report.

Public Policy- Some Issues that Matter Fall 2015

Our new program year follows on a generally successful one last year. In particular, a variety of positive legislation for Maryland women was passed that included moving on the issue of *Human Trafficking* in our state. That legislation is well summarized by the Maryland Coalition Against Sexual Assault's (MCASA) summary which can be found on its website for the summer (see Human Trafficking in Maryland: The State of the State at: http://www.mcasa.org/human-trafficking-in-maryland-the-state-of-the-state). There is more to do in this area on the local and state level, here are some other important issues this coming year.

Though Maryland, New York and Washington, DC are the three states with the lowest *Gender Pay Gap* in the United States, Maryland does not have equal pay. AAUW members should let their state legislators know that everybody wins when women get equal pay. AAUW reminds us that the Pay Gap is even worse for Black Women everywhere (see http://www.aauw.org/2015/07/21/black-women-pay-gap/).

What about *Paid Sick Leave*? In July, Montgomery County, MD., became the first county in Maryland to establish a paid sick days' standard. The County Council allows workers at businesses with five or more employees to earn one hour of job-protected paid sick and safe time for every 30 hours worked, up to 56 hours annually (approximately seven days for a full-time worker). Workers at businesses with fewer than five employees accrue up to 32 paid hours and 24 unpaid hours annually. This time can be used by workers to care for themselves or for a family member who is ill or needs preventive or medical care, and to care for family under certain circumstances in the case of a public health emergency, due to a family member's exposure to a communicable disease or for the employee or family member to obtain services to address the effects of domestic violence, sexual assault or stalking. Covered family members are a spouse, child, parent, former primary caregiver, legal guardian or ward, grandparent, sibling, grandchild, parent-in-law, or spouse of a grandparent or sibling.

In 2015, the Maryland Legislature attempted to bring *Paid Sick Leave* for a vote, through The Maryland Healthy Working Families Act. Unfortunately, no action was taken after hearings. Can we do better this year? We hope so. Women's pay, women's jobs, good child care, and a variety of other family matters would be well-served by paid sick leave. Most often the lowest paid women do not have this benefit.

On a state and local level *Campus Safety* is an important issue for everyone. AAUW members should become familiar with the kinds of programs local public schools and colleges have to address campus safety. AAWU has a variety of materials to help branches develop programs in this area, with its *Ending Campus Sexual Assault Tool Kit* found at http://www.aauw.org/resource/campus-sexual-assault-tool-kit/. This Tool Kit includes material such as *10 Ways to Fight against Sexual Assault on Campus*, ideas on funding sources to host an event, and ways that faculty and staff can help.

AAUW public policy leaders hope AAUW members will get involved and take the time to work with these public policy initiatives. All members can encourage their branch to develop a public policy program for the coming year. AAUW public policy leaders invite all AAUW members to come to Annapolis during the 2016 session and be in touch with ideas and questions.

The Book Group of the Harford Branch of AAUW has been meeting for ten years now. Every month the group reads and discusses a book that everyone agreed upon. The group reads all kinds of books, both fiction and nonfiction. A favorite type is a book that describes a woman overcoming difficulties to become a success.

The responses to the books vary. Almost every book has readers who loved it, readers who hated it, and everything in between. One book was beloved by everyone who came to the discussion--Maya Angelou's, I Know Why the Caged Bird Sings. Each reader at the discussion had favorite lines marked to read and share with the group. The enthusiastic readers spent most of the lovely time together quoting from the book. What metaphors!

Many could not shake off disapproval of Madame Bovary, no matter that in the novel of the same name, by Gustave Flaubert initiated modernism and influenced Marcel Proust and James Joyce. Some loved Anthony Doerr's *All the Light We Cannot See* and found the blind heroine endearing; others found the book long-winded and confusing.

Whether or not everyone loves or even likes the book does not matter. The group delights in getting together, sharing delicious snacks, talking about their lives, and of course offering impressions of the books. Through learning what each person likes or doesn't like, the group has come to appreciate all of similarities and differences of all of the participants.

Toni Bram GED Scholarship Project at Harford Branch

The Toni Bram GED Scholarship Project (named after our late branch member who originated it) is a fund raiser which provides scholarship support for students enrolled in Harford Community College's GED Project®. Member contributions are made out to the Harford Community College Foundation and presented to the HCC Director for Adult Developmental and Literacy Programs.

Normally all contributions received for the Toni Bram GED Scholarship Project are presented to HCC in January. However this year HCC's GED scholarship fund was in dire straits—there were no funds available for any of the incoming September students. Our leader for this project quickly determined that we could not wait to do a solicitation by regular mail; instead an urgent e-blast was sent out to all of our members. Their response was immediate and remarkable. So many responded so quickly with their contributions to the Toni Bram GED Scholarship Project that on August 29, 2015 checks totaling \$955 were presented to Brandy Naughton, HCC's Director for Adult Developmental and Literacy Programs. As more donations are received they will also be presented to HCC to provide scholarship support to the incoming January 2016 students.

<u>GED Graduation Ceremony:</u> HCC's GED graduation ceremony took place the evening of August 14, 2015. Sixteen graduates proudly received their GED diploma. Family members, friends, HCC instructors and administrators, and community members were there to celebrate their achievement. (There were more who graduated but they were not able to attend the ceremony.) This is the first GED class to graduate since computerized testing was instituted in 2014. For some, not only did they have to learn all the subject matter in their classes, they also had to overcome their fear of testing on a computer.

A couple of the graduates spoke movingly of the difficulties they have overcome and their future plans. Here are a few examples. Dakotah wants to get a degree in forensic psychology, with a focus on serial killers and then work with the FBI. Sarah, at age 16, is already signed up for some HCC classes. She wants to become an English professor and write the great American novel. She reflected her passion for her goal when she expressed her personal motivating, mantra, "Don't just reach for the stars—reach up for the whole galaxy."

Two of these graduates received support from our contributions—a mother and her son. One of our members had an opportunity to talk with them after the ceremony and both recipients expressed their gratitude for the scholarship help. This member was impressed by the commitment the two of them had

made to obtain their diplomas, especially when they described all the delays in their classes necessitated by bad winter weather. They indicated that their commitment to education will not stop now that they have their GED diploma; both plan on taking credit courses at HCC this fall. They, as well as their fellow graduates, are on their way to a brighter future.



Parking

Edison Park Fast, 100 West Fayette Street (410-659-5824) is the closest to the MWHC. The rate is \$9 on Saturday. You can get a \$1 discount by reserving a parking spot on-line at http://www.parkfast.com/downtown-baltimore-fayette, printing your confirmation, and presenting it upon payment for \$1 off. The lot is one block off Charles St. Drive down (under big yellow Edison Sign) mid-block behind the two hotels. As you come down the ramp, the closest parking is generally taken by hotel guests. Go to the further side (Lexington ST) on any floor. Park on the Lexington St. side, near the elevator to the Plaza Level. Hit P on the elevator button and go up to the Plaza floor level. When you get off the elevator, turn around and walk toward Lexington ST (west). The MWHC is on the ground floor of 39 W Lex (old BGE Building) on the right side/street side of the building.

Some metered street parking is available. Parking is limited to 4 hours.

Driving Directions to Edison Parking (100 Fayette Street)

From Washington, D.C., and Points North or South of Baltimore via I-95 North: Follow I-95 to exit 53 (I-395 North) to Downtown/Martin Luther King, Jr., Blvd. Stay to the left and follow signs for "Downtown." Once you exit to the left towards "Downtown," merge to the right and follow the flow of traffic towards the Inner Harbor. Make your first left on to Charles Street.

From Points West of Baltimore via I-70 East: Take I-70 East to I-695 South towards "Essex." Follow I-695 South to I-95 North. Take I-95 North and then follow the directions above from the South.

From Points North of Baltimore via I-83: Take I-83 South to Downtown Baltimore. Merge right on to Fayette Street. Continue on Fayette Street, staying to the right

From Charles Street, make a left on to Saratoga Street, and then a left on to Liberty Street. The Maryland Women's Heritage Center is located on your left at the corner of Lexington and Liberty Streets.
