AAUW Maryland Fall Conference: "All in the Family" Salisbury September 17, 2011

We have to check the back-up time on the bridge. Hate just sitting on the road to get to the beautiful Eastern Shore. Wait! It's fall, not summer. This is the perfect time to go to Salisbury.

The AAUW Maryland Fall Conference will be held in Salisbury, with two very well-known speakers who have succeeded in exciting, non-traditional careers. AAUW Maryland is rich in such talented members. These two, with some help from other out-of-the-ordinary members, will share how the mission of AAUW has challenged them and guided them in their personal development.

Cleopatra Campbell, a member of AAUW for almost 50 years, was recently elected Judge of the Orphan's Court in Frederick, MD. Cleopatra noted, "I am really proud to sit on the Orphans' Court as a woman. If I were not there, there would be three men." She will share her experience running for office and explain what the court is. She will also give information about the power of attorney and advanced directive; Cleopatra calls her talk "Life and Death in Maryland: Powers of Attorney, Living Wills and the Orphan's Court.

Then, Janet Crampton will discuss the exciting science of geology, and will show examples of rocks from her collection (as well as one belonging to my granddaughter, handed down from me through my daughter). Janet believes that rocks tell stories. But story details lie hidden in physical and chemical properties—size, shape, color, feel, taste, and arrangement. Work with rocks long enough and you develop a sense of a rock's history. Working in AAUW to break through barriers to equity brings the same sense of history, of common characteristics among different barriers and characteristics unique to particular situations. The longer you keep at it, the more you understand how important are AAUW's efforts.

She will also discuss the sewage treatment plant in Salisbury, with help from Betsy Matthews, who ran that plant until her retirement.

Come early and enjoy the scenery and historic sights. The registration sheet gives information about a place to stay. It's a great time to get to know Salisbury and the Eastern Shore--no beach traffic!

The Orphan's Court oversees the administration of estates, the distribution of assets of a deceased person, and resolves disputes that may arise during estate administration. Janet received her Bachelor of Science degree in Geology from Indiana University in Bloomington in 1955, and her Master's degree from Mount Holyoke College in 1964. She has had a variety of work experiences, including: junior high school science and math teacher; member of boards and commissions including the late Montgomery County Commission for Women and the late Montgomery County Board of Education Title IX Advisory Committee; consultant in women's equity issues and high school science materials; and home caregiver.

Message from Joyce and Mary Anne

Maryland can be proud of the representation, planning and impact they had at the Association Convention in June. Several members were able to attend at least part of the convention, and many stayed for the entire event. Marcia Posner and Joyce Graf, members of the planning committee, made a significant difference in how others from across the country felt about our region and our expertise. And we made quite an impact with Maryland's unique AAUW scarves that we sold. Below are some comments arising from what happened at the Convention.

Mary Anne spent several hours, as did others from Maryland, working at ShopAAUW. This is the table where various items with the AAUW logo are sold. Among items available were book bags, pins, t-shirts, and hats. However, the Maryland scarves were not sold at that location. During the time Mary Anne worked there, many came to the table and asked where to get the scarves. The staff working at the table took note of the interest in the scarves, and we are hopeful that this project will be picked up by ShopAAUW. Negotiations are in progress now.

Many discussions involved recruitment and retention of members. Other states and branches are exploring alternatives to the traditional structure with varying degrees of success. The Maryland online branch is one example of alternatives that were mentioned. Congratulations to Jennifer Ingram for undertaking this adventure.

Do you remember P.E.A.R.L? This was the acronym to help us remember the mission of AAUW, but it was not as easy to remember as it should have been. Welcome to the new acronym: REAP with AAUW. AAUW supports equity for women and girls through Research, Education, Advocacy and Philanthropy. Need an elevator speech? There you have one.

As to our mission, AAUW is celebrating 130 years as an organization and its success in reaching a

major goal. When AAUW was first started, women were often excluded entirely from higher education, and fields in which women studied were limited. In fact, there was a general belief that women with college educations were unable to have children, not because they were not socially accepted by men, but because education caused physical sterility. AAUW began as an organization to provide opportunities for women to study and complete college degrees, as well as advanced degrees, and to provide opportunities for them to be professors.

Now, 130 years later, we can celebrate that AAUW has been successful in this attempt. Admittedly, not all is equitable, but women outnumber male college graduates and graduate students. More women are accepted as professors, even though there is some disparity there. However, overall, we can say that AAUW has accomplished this major goal.

So what to work on now? Mary Anne left convention feeling that AAUW is moving more towards advocacy. Equity for women and girls is still a distant reality, and many current issues are thwarting that goal. The Pay Equity Act is still in Congress, making no progress to passage. Health issues, including Social Security, Medicare, and insurance costs, impact women and children far more than men. Recent Supreme Court decisions have made equity harder for women to achieve.

Our work is far from over. There is still a great need for equity for women and girls. Education is a part of that, but in a different light. These issues need to be brought into the spotlight through research and educating the public. Philanthropy enables this research and education. Let us work together to educate others about the need for AAUW and its work, let this become our driving force, and use it to continue to make a difference for women and girls.

LAF Update

Since 1981, LAF has disbursed nearly two million dollars to more than 100 plaintiffs to help offset their legal fees in sex discrimination cases. Before 2009 LAF only supported cases in academia. LAF now supports select cases in any workplace.

Cioca v. Rumsfeld and Gates

In May, the AAUW Board of Directors voted to accept two important and exciting cases. Cioca v. Rumsfeld and Gates, and Parker v. Franklin County Community School Corporation. AAUW is awarding them \$3,000 and \$4,200, respectively.

Sixteen veterans and current members of the U.S. military who were allegedly raped, sexually assaulted, and harassed while on active duty filed a lawsuit in February 2011 against the Department of Defense. The plaintiffs charge that the agency violated their constitutional rights by allowing a culture of assault and by failing to act on complaints.

Parker v. Franklin County Community School Corporation

The primary issue in this case is whether the scheduling of girls' basketball games on less desirable days violates Title IX of the Education Amendments of 1972.

Plaintiffs showed that most boys' games were played in prime time (Friday and Saturday nights)

while most girls' games were played on weekday nights. Such scheduling unfairly placed academic burdens on the girls, who competed on school nights, were deprived of crowd support, and were made to feel like second-class athletes.

The original suit was dismissed in 2010 in summary judgment, the U.S. District Court for Southern Indiana saving that the school districts were arms of the state of Indiana and could not be sued. The plaintiffs appealed, and the case is under review by the 7th U.S. Circuit Court of Appeals in Chicago. "This case could set significant precedent on whether school districts are arms of the state and therefore immune from suit in federal court," according to an

Sun v. University of Massachusetts, Dartmouth

Lulu Sun, an English professor at the University of Massachusetts, Dartmouth, had filed against the school with the Massachusetts Commission Against Discrimination, claiming sex and race discrimination in the promotion process. In a first-step victory, on June 1 the commission hearing officer ordered her promotion to full professor and awarded her lost wages of about \$154,500, plus \$200,000 in emotional distress damages. The university will be charged a civil penalty of \$10,000, Its administrators must attend a training session on employment discrimination law. The university plans to appeal the decision

Board Votes to Disburse \$38,000 to Ongoing Cases

In May, the AAUW Board of Directors voted to contribute funds to five ongoing LAF cases. The board gave the Mansourian Title IX case the largest amount to help cover the plaintiffs' current trial costs. Other case support: Jaureguito v. Feather River Community College, California, \$4,000; Mansourian v. Regents of the University of California, \$14,800; Sun v. University of Massachusetts, Dartmouth, \$4,000; Thein v. Feather River Community College, California, \$4,000; and Wartluft v. Feather River Community College, California, \$4,000.

AAUW Convention Lobby Day

The "Big Teal Machine", almost 700 strong, sprung into action. Members from across the country spread their influence over and through Capitol Hill seeking support for the Campus SaVE Act and the National Women's History Act, as well as an urgent need to protect and strengthen Social Security.


The National Women's History Act (S.680, H.R.1269) will permit the Federal Government to sell Federal land to the NWHA for the building of a museum providing recognition of women and their accomplishments. The Campus SaVE Act (S.834, H.R.2016) is an anti-campus sexual assault bill that improves the Clery Act of 1990 by requiring colleges and universities to clarify and make available their policies of reporting and disciplinary actions relating to sexual harassment, assault and violence. Also included will be prevention programs and assistance for victims.

The results of the Big Teal Machine were extensive and successful. Office visits organized by the AAUW Public Policy Team included over 100 members of the House of Representatives and almost 90 Senators. Using the Two-Minute Activist system (<u>http://</u> <u>capwiz.com/aauw/home/</u>), 4,000 messages were sent about the Campus SaVE Act, over 1200 about the Women's History Museum and almost 5,000 supporting Social Security. The feedback from Senators' and Representatives' staff was fantastic. The Women's History Museum Act now has 13 additional co-sponsors in the House. The Campus SaVE Act added 5 co-sponsors in the House and 4 in the Senate. Friday was, indeed, a Big Teal day!

The bipartisan Campus Sexual Violence Elimination (SaVE) Act would help to end sexual assault and violence on campus by requiring schools to spell out their policies, conduct prevention activities, and ensure necessary assistance for victims. Almost a decade ago, AAUW's own research revealed that 83% of girls and 79% of boys reported having experienced sexual harassment in particular, and over one in four students stated that harassment happens "often." The damaging impact on the educational experience and personal psyche of these students can be extensive. Co-sponsoring this act is a step towards ensuring the safety of our future professionals.
