AAUW Maryland Convention: Maryland Health Care Issues April 30—May 1, 2011

There is health care for individuals and for our Association. What does that mean? Come to the Spring Convention to find out.

What do you know about the health care legislation and what do you want to know? We will hear from Joanne Grossi, Regional Director of the U.S. Department of Health and Human Services for Region III, who will speak to us about this and answer your questions and concerns about how you will be affected. Hearing differing opinions and "spun facts" from both sides of the aisle can cause confusion and doubt. We need to know the actual facts. Be prepared with your questions.

Want to know what is happening to ensure proper health care in Maryland? Can we have health care for all? Dr. Beilenson, Health Officer of Howard County, will speak about that, as well as what Howard County is doing under the title of *Healthy Howard*.

We will be holding the National Convention in Washington, DC, June 16 - 19. **We**, <u>not</u> they. We remain a strong group by working together. If we don't, we will become weak. Christy Jones of the Association will talk to us about how plans are coming along for the

2011 Convention Speakers

Peter L. Beilenson, M.D., M.P.H.



Peter L. Beilenson, M.D., M.P.H., currently serves as Health Officer of Howard County, Maryland. Dr. Beilenson brings 18 years of experience in public health leadership, having previously served as the Baltimore City Health Commissioner under the administrations of mayors Kurt Schmoke and Martin J. O'Malley.

Dr. Beilenson received his undergraduate degree from Harvard College, Medical Doctorate from Emory University School of Medicine, and Masters in Public Health from the Johns Hopkins University Bloomberg School of Public Health.

During his tenure in Baltimore City, Dr. Beilenson's vision led to expanded drug treatment programs in Baltimore, improved immunization compliance, a wide range of extremely effective lead poisoning prevention initiatives, juvenile violence prevention, and the creation of the state-wide initiative for universal health coverage in Maryland - Health Care for All. In Howard County he has launched the Healthy Howard Access Plan, a first-of-its-kind program

in the country that will provide comprehensive, affordable health and wellness services to the uninsured of Howard County.

Dr. Beilenson has received many national and local awards for his innovative health policies, including being the first-ever recipient of the Milton and Ruth Roemer Award for creativity by a local health official from the American Public Health Association.





In April, 2010, Joanne Grossi was appointed by the Obama administration as the Regional Director of the U.S. Department of Health and Human Services for Region III, which includes the states of Pennsylvania, Delaware, Maryland, Virginia, West Virginia and the District of Columbia. As Regional Director, Ms. Grossi serves as the key representative in this region in working with federal, state, local and tribal officials on a wide range of health and social services issues.

Prior to this appointment, Ms. Grossi served for seven years in the administration of Governor Edward G. Rendell, first as Deputy Secretary of Health and later as the first- ever Director of the Office of Women's Services.

Before joining the Governor's administration, Ms. Grossi served for 13 years as a Senior Technical Advisor in the Bureau of Global Health at the United States Agency for International Development, where she oversaw international health programs in developing countries.

Earlier in her career, Ms. Grossi served on the staffs of Congressman Peter Kostmayer and Ambassador Millicent H. Fenwick at the American Embassy in Rome, Italy.

Ms. Grossi earned her master's degree in International Public Policy at the Johns Hopkins University's School of Advanced International Studies and completed additional graduate education at the Johns Hopkins University's School of Public Health and Hygiene.

To your health!! Our best wishes for good physical and financial health to all! AAUW affirms that everyone is entitled to health care that is high quality, affordable, and easily accessible. This position stems from AAUW's 2009-2011 Public Policy Program, which advocates "increased access to quality affordable health care."

Good health means health care security, which is tied to economic security. On average, women earn less than men and use more health care services than men do. Women are less able to afford insurance or care and are more vulnerable to health care insecurity.

In March 2010, President Barack Obama signed legislation that produced a number of substantial changes to the current U.S. health care system. AAUW's three main health care priorities — an end to gender rating, protection of women's reproductive health services, and ensuring coverage of preventative care — were directly addressed in the final legislation, with varying degrees of success and setbacks. Check out the implications of these changes and other health care issues at the state convention in Beltsville, MD.

Good times with friends contribute to good health. Although it may sound boring, the board meeting always

has stimulating discussion about issues of importance to the state. The workshops offer an opportunity to learn of successes from other members and to contribute your own. The keynote speakers are always inspiring. The Sunday program is always relaxed, entertaining and refreshing. If you have never attended a state convention, then this is the year to experience an invigorating dose of AAUW tonic: women united in a common purpose to support education and equity for women and girls.

Currently, Paschen is the Academic Advisor at Lincoln College of Technology where she is also a Skills Assessment Specialist. Additionally, she is an assistant adjunct instructor at Bowie State University. The last 25 years have seen Paschen writing feature stories and columns for publications such as Baltimore Magazine, Prevention Magazine, Men's Health, Warfield's (business magazine), the Columbia Flier and numerous national dailies including the San Diego Union Tribune and the Cleveland Plain Dealer. As an investigative reporter, she has lived in homeless shelters with at-risk families, interviewed victims of incest and domestic violence, tracked down and interviewed newly released but missing schizophrenics for Johns Hopkins' researchers, and engaged in numerous projects requiring the skillful hand of a compassionate observer. She graduated with honors from the University of Maryland with a B.A. in English/Pre-Law and attended graduate school at Johns Hopkins University where she studied Regional and Urban Planning. Hollis is a member of the Howard County branch.

Jeri Rhodes is the President of the Kensington-Rockville Branch of AAUW. She has been a member of that branch since she moved to Kensington in 1983. She is serving as a member of the Finance Committee and the Audit Committee for AAUW and is currently serving her first term as Secretary of Maryland AAUW. She is currently employed as the Executive Director of a law firm in Washington DC and has been in the legal administration field for many years.

Final Words from Your State Treasurer

My second term as AAUW MD's treasurer is quickly coming to an end. To make it easier for my replacement, I thought a few reminders are in order. First of all, any officer, committee chair or other member entitled to reimbursement for certain AAUW-related expenses must fill out an Expense Voucher. Yes, I know, I've let some of you slide! Some of you just send me an e-mail, tell me what your expenses are and unless I need receipts, and even sometimes when I do need receipts I complete the form for you, wait for your receipts if needed and then reimburse you. Incidentally, receipts are needed for everything but mileage and tolls.

Let's make it easy for our next treasurer. Fill out the Expense Voucher and mail it to your next treasurer.

A copy can be found on our website which you can download and print. It is in Word format.

The next thing of which I want to remind you is the time limit for filing expense vouchers. At the winter board meeting in 2007, a motion was made and passed making it a requirement to file expenses within 30 days of their occurrence. Doing this creates a more timely snapshot of our expenses. Some folks were waiting until near the end of our fiscal year and filing for the entire year. This has not been enforced since some folks were not aware of this requirement. This article serves as a reminder of this requirement, so not knowing about this should no longer be an excuse.

CELEBRATING AND HONORING MARYLAND WOMEN IN STEM

Women, in general, have faced discrimination and opposition to gain recognition in the historically maledominated fields of science, technology, engineering, and mathematics (STEM). However, in spite of barriers, many Maryland women have been firsts and founders in the STEM fields, making lasting contributions and setting examples for other women and girls.

The Maryland Women's Heritage Center, which opened in June, 2010, in downtown Baltimore, is committed to telling the stories of these Maryland women and to "Add herstory to history to tell our story." It is the first state-based women's history museum and leadership center in the nation, and is currently developing a Timeline Exhibit, Explorations and Discoveries: Maryland Women in Science, Technology, Engineering, and Mathematics.

The Heritage Center has asked Maryland AAUW to participate in this exciting and innovative project. We can be involved by:

- Identifying specific women to honor
- Providing photographs, artifacts, memorabilia and resources to make the Timeline interactive and informative
- o Assisting in funding the project

Among the current supporting organizations are Women of Goddard, Maryland Space Business Roundtable, Association of Women in Science, Multinational Development of Women in Technology, the National Science Foundation, Clark School of Engineering, Johns Hopkins Applied Physics Lab, the Maryland State Department of Education, and Girl Scouts programs to encourage girls to participate in STEM fields.

Go Global!

Women Graduates USA and the Virginia Gildersleeve International Fund are two organizations with international connections that have active AAUW members from Maryland.

Women Graduates USA (WG) has succeeded AAUW as the U.S. national affiliate of the International Federation of University Women (IFUW). WG is focused primarily on international connections and issues. Last summer, a delegation that included Jean Thompson, Jeri Rhodes. and me, traveled to Mexico City for the Triennial meeting. The next meeting (in 2014) will be in Istanbul, Turkey. Recently, members contributed the funds needed to ensure that Armenia and Cameroon could continue to be members of IFUW. WG's current areas of focus are the ratification of the Committee on the Elimination of Discrimination Against Women by the U.S. Senate, advocacy for access to education for girls, world wide, and awareness of the extent and implications of trafficking of women and girls worldwide. It is an on-line organization, operating through the internet. Go to the website at www.wg-usa.org to join.

The Virginia Gildersleeve International Fund (VGIF) is an independent foundation founded in 1969 by members of IFUW to provide small grants to women in developing countries to empower women and girls. Its members have funded more than 350 projects in 72 countries with grants of \$3-5,000.

A few examples of the impact of recent grants:

- Girls in rural northwest Haiti now attend school rather than travel for hours to the nearest grain mill to process their families crops;
- In Brazil, 60 young girls living in poverty who had few opportunities beyond being maids or prostitution are staying in school;
- In Tbilisi, Georgia, where nearly 40 percent of pregnant women experience domestic violence, doctors are identifying those who have suffered from abuse and referring them to the Georgian Women's Center's hotline;
- In Fiji, following a series of workshops for rural students and their teachers on science and technology, enrollment by girls at the University of the South Pacific has increased dramatically; and
- In the Democratic Republic of the Congo, 90 women and girls are producing soap and bread to sell locally, and young mothers are able to send their children to school and contribute to their medical expenses.

Membership Update

The 130th Anniversary Sale!

AAUW is celebrating its 130th anniversary this year and one way to celebrate is with increased membership. To accomplish this goal, AAUW has established some sales on different parts of the membership issues.

If your branch increased membership by 7% from 2/1/10 to 2/1/11, it will be awarded one free membership for a new member. If the increase was by 13%, the branch will get 2 free memberships. Each branch will be notified about free memberships in April and how to use them via e-mail. Note the "free" part is for national membership, not state membership. The branch must decide whether to pay the state dues and waive the branch dues. This is similar to the free memberships earned through Shape the Future membership campaigns.

Another feature of the 130th Anniversary Sale is that people in graduate school have national membership dues of \$18.81 for this year. State and branch dues are not impacted. Also, colleges and universities can become partners for \$130 for a year, regardless of the size of the institution, so encourage your local C/Us to join and get free e-student affiliate membership for all undergraduates at the school, in addition to other benefits. Remember dues are payable by June 30, 2011, for membership through June 2012.

Branch members who recruit at least one new member will have their names entered into a drawing for two prizes. One drawing will be held at the 2011 National Convention in Washington, D.C., and the other will be held in November 2011, at the end of the campaign. Winners of the first drawing are not eligible to win in the second drawing. Those entered in the drawings are eligible to win one of 130 FREE AAUW memberships.

So, the moral of the story is to continue your recruitment efforts – you are a winner no matter what.

Sponsor a Mock-SAT Exam!

Does your branch want to host a relatively easy educational project and fundraiser? Try a mock-SAT exam and follow-up strategy session. AAUW Howard County just hosted its second one this year and netted over \$700, and the students and parents really appreciated our efforts.

How did we do this? AAUW has a partnership with The Princeton Review (TPR), a national company that holds classes in various college entrance exams and how to succeed at them. Howard County contacted TPR about conducting the mock-SAT exam to determine the costs, rules, what was needed, etc. We found that TPR does not charge for administering the mock exams or the follow-up strategy session. Six-week advance notice is needed, and TPR gave us a list of what we would need for the room and what we need to tell the students. We also learned that they administer the mock ACT, GRE and other graduate school entrance exams.

This year Howard County was able to arrange for free space for the mock exam and follow-up session, and we had 48 students attend at \$15 each. Two more paid but did not come, so that was \$750 less expenses for refreshments. The most efforts went to registration, which was done in advance via phone and e-mail, and publicity – sending information to schools local papers, websites and organizations. If you decide not to charge for the event, TPR can handle registration.

AAUW Legal Advocacy Fund Supports Class Action Against Wal-Mart

Can employees band together to sue a company because company culture maintains a hostile work environment? Women who have worked for Wal-Mart insist that is their right in their suit, Dukes v. Wal-Mart Stores, Inc.

AAUW supports the six plaintiffs, who want their cases expanded to a class action suit against Wal-Mart for systematic sex discrimination against all the company's female employees. The class would be the 1.6 million women who are current or former Wal-Mart and Sam's Club employees. In January AAUW Legal Advocacy Fund awarded \$20,000 in financial support and has also filed an amicus brief with the U.S. Supreme Court, who will hear the case March 29.

In 2001 the plaintiffs were granted class certification, which Wal-Mart appealed. Class certification was granted at further court levels. Wal-Mart appealed each certifica-

tion, finally appealing to the U.S. Supreme Court. The court will decide if all these employees can sue as a class or if each must sue on her own time and money. (Comment: After 10 years of litigation, only legal technicalities have been addressed. The merits of plaintiffs' claims have yet to be heard.)

"AAUW strongly believes that these women's voices should be heard and that they should be able to stand together to fight for their families' economic well-being. Class action cases also have a much stronger deterrent effect, showing the business community that discrimination is not good for the bottom line," said AAUW Executive Director Linda D. AAUW Honored with Cy Pres Award

AAUW received \$23,500 in February because it breaks through barriers to women's equity. AAUW is one of seven charitable organizations advancing workers' rights and equity selected for a cy pres award from the settlement of the Novartis gender discrimination case.

The case, *Velez v. Novartis Pharmaceuticals Corporation*, started in 2004 and went to trial in 2010. The jury found for the class of 5600 female sales representatives (6200 after settlement) who claimed pay, promotion and

pregnancy discrimination. Final settlement in November 2010 was \$175 million and a commitment by Novartis to change how it treats its employees. Of the settlement, \$164,500 was for cy pres awards.

"Cy prés comme possible" means "as near as possible." In United States class action settlements, the term refers to a court-approved grant from settlement funds to a charitable organization that works for the rights for which the class members sued and won the case.


