## **President's Message**



This summer has been a whirlwind! – a long camping trip with my husband (and thank you to Debby Chessin for stepping up to take on tasks while I was deep in the woods), followed by the final weeks leading up to the Summer Conference and now preparing for the Fall Conference. Thanks to both branches who stepped up to host: Kensington-Rockville and Gaithersburg. It's been wonderful to continue to gather together in person.

The Summer Conference on Inequalities in Health Care Affecting Women and Girls was enlightening to say the least. We had three amazing speakers, Dr. Agueh, Dr. Simpson and Dr. Robinson. A few of the things I learned:

 In some states Black mothers have worse outcomes than mothers in many low- and middle-income countries. For example, birth is more likely to be fatal

for Black women in New Jersey, Texas, and Louisiana than for mothers in Guatemala, Algeria, and Mongolia.

- When undergoing gynecologic surgery, Black, Latino and Asian women are less likely to have minimally invasive surgery and are at greater risk for complications following surgery.
- One in four U.S. women will have an abortion by age 45. Twothirds of abortions occur at 8 weeks or earlier and 89% occur in the first 12 weeks. Abortion rates don't drop when the procedure is outlawed.

My focus for the next two years will be exploring these and other inequalities that affect women and girls. You'll hear more from me on these topics and how we can take action in the coming months. Let's work together to find innovative ways to bring the health care issues of women to the forefront and work towards making change.

Please join us starting at 9:30 for a half hour of socializing, networking, coffee/tea, and snacks. President Tracy Lantz will open the program at 10:00 am. The beginning of the program will include a lively discussion of the high points of the Gaithersburg Branch from 1972 to 2022 – five decades! Where were you in 1972?

#### Public Policy Update

AAUW Maryland's public policy advocates are just getting warmed up for the upcoming election on Tuesday, November 8, and preparations for the 2023 General Assembly January 11-April 10, 2023. Debby Chessin and Roxann King will serve as co-Vice Presidents for Public Policy for AAUW Maryland through June 2024. The state

committee for public policy includes chair persons from the branches and meets monthly on the third Thursday at 7:30 p.m. on Zoom.

Several branches are participating in voter registration activities or co-sponsoring candidate forums, usually with the League of Women Voters or the board of education. If your branch needs support from AAUW MD for a forum, please contact Roxann King (roxann.king1@gmail.com) or Debby Chessin (dachessin@gmail.com) and submit a mini-grant application through the AAUW Maryland website. The deadline for mini-grant submission is October 15. If funds are needed for a pre-election activity, we will rush those funds to you.

As mentioned, the new mini-grant program to provide support for diversity or public policy branch activities is up and running. Applications are posted on the AAUW Maryland website. The 2022 deadline for applying has been extended to October 15. We modeled this program after the existing AAUW Virginia program.

Member Anita Rosen is representing us on the planning committee for the virtual 2023 Women's Legislative Briefing, January 29. This will be the 43<sup>rd</sup> year for the Briefing, hosted by the Montgomery County Commission for Women. AAUW Maryland will again be a sponsor. If you wish to work with Anita in promoting this event, contact her at anitarosen123@gmail.com. This event is the biggest event in Maryland of its type, drawing individuals, sororities, advocacy groups, lawyers and politicians from throughout the state to discuss the legislation needed to advance the welfare of women and their families.

AAUW Maryland is a member of a coalition known as the Maryland Legislative Agenda for Women. Debby Chessin represents us on the board of MLAW this year. The Fall Conference on November 12 in person at the Silver Spring Civic Center includes the presentation of new bills supporting women or their families by the sponsoring advocacy groups. Following the conference, individual and organization members vote to determine which bills will comprise the seven or eight bill agenda for 2023. These bills become the core of our legislative agenda. In 2022, four of the eight bills supported by MLAW members became law. Two others were very close to passing. (Details are in the MLAW 2022 Final Report under April 26 on the MLAW web page.) AAUW Maryland members and branches are encouraged to join MLAW to strengthen our voice in determining the agenda for the year. MLAW membership applications are available at https://mdlegagendaforwomen.org/join-mlaw/.

Much of the focus of AAUW's national agenda in 2022 was on support for Roe vs. Wade. The emphasis for abortion freedom has now shifted to state advocacy. In Maryland, protections for women's health rights are already guaranteed by our state constitution. The national focus now seeks prevention and remediation for human trafficking. Human trafficking flourishes nearby, particularly in the I-95 corridor, at transportation hubs

and in the vicinity of large sporting events. Emails, letters and phone calls to our senators and congress persons continue to be the best ways that we can make a difference. Don't stop at one email: continue to pester your legislators. Your emails become piles of evidence of support. AAUW continues to provide easy email access to legislators for members through the Two-Minute Activist. Join it, if you haven't, and read the Washington Update monthly to stay current on our national policy.

#### Your nomination for Maryland's 2023 Woman of Distinction is due October 1st!

At the August 2022 Board meeting, we approved AAUW MD's continued sponsorship of the 2023 Women of Distinction Ceremony at the \$20K level. We will announce the selection of the 2023 Maryland Woman of Distinction Honoree at the October 15th, 2022, Board meeting.

Earlier in the summer, several Board members met via Zoom with Gloria Blackwell, CEO of AAUW National and others to discuss their plans for the 2023 National Conference for College Women Student Leaders (NCCWSL) and the Women of Distinction program. They assured us that they want to have the event in person at the University of Maryland, College Park, but reserve the right to switch to a virtual event if necessary. They also greatly appreciated the \$20K yearly donations we have given them for many years. The past two years have been virtual, but we have high hopes that we'll see it at College Park again.

The conference will be held late May/early June 2023. Our most recent honorees include Judy Carbone, Kate Campbell Stevenson, Yvette Myrick, and Pat Stocker. We know there are many others out there to be honored, but we need YOUR input!

The criteria for nomination as the AAUW MD Woman of Distinction include the following: (1) the honoree will inspire the college women attending the conference; (2) the honoree will inspire others to contribute to the fund in her name; (3) AAUW membership and activities should also be included. The woman nominated must also be available to attend the Women of Distinction ceremony in late May/early June, 2023 and give a short speech and possibly be part of a panel discussion. A brief biography and description of how the nominee meets the criteria should be sent to Bea Dane at bea\_dane@comcast.net no later than October 1st. A committee will review the nominations and recommend the honoree at the October 15th State Board meeting for approval.

In addition, thank you AAUW Maryland for your patience as I get organized and acclimated in this new role. Lastly, please join me in expressing utmost appreciation to Jacqueline (Jacki) Gray for all her hard work in advancing this topic for AAUW Maryland over the past 3 years. She spearheaded many initiatives to build on.

#### AAUW DIVERSITY AND INCLUSION OFFICERS TRAINING COMING IN SEPTEMBER 2022

The first phase of the AAUW Diversity Officers training will take place virtually on September 10 and 17 and is not just for the officers, anyone in Branch leadership interested can attend. The State Presidents will receive more information from AAUW National to disseminate to their Branches. The trainings will accommodate, time zones of the membership; and the first phase will focus on introductory information, such as roles, terminologies, and tools and resources.

#### IN THE WORKPLACE

I had the opportunity to attend a June 2022 presentation on inclusive leadership and developing a diverse medical communication pipeline by Dr. Dean Colston (technical editor, health/medical writer, and social media manager). Dr. Colston discussed, among other topics, the benefits of an inclusive workplace and how it affects organizational success. Inclusive leadership is a leadership style that embraces, encourages, and taps into the creativity and ideas that come about in diverse groups (Shapiro *et al.*, 2011). Dr. Colston shared that this leadership style is by far not new but does not come naturally to some. It takes time for people to learn the vocabulary and the concepts. Important to the process are leadership development coaching and training. [Permission was granted to use this information]

Recently announced: The Federation of American Societies of Experimental Biology (FASEB) announced their inaugural Diversity, Equity, Accessibility, and Inclusion (DEAI) Programs: Career Advancement and Research Excellence Support (CARES) and Leadership Excellence and Appreciation of Differences (LEAD). CARES provides financial support (\$5,000) to alleviate financial burdens associated with caregiving. LEAD is an innovative mentoring program that pares senior-level professionals with junior-level mentors to gain different perspectives. FASEB, composed of 28 scientific member societies, with more than 115,000 researchers worldwide, is committed to fostering DEAI in the biological and biomedical sciences. #### **Garrett County Branch**

Garrett County celebrated Women's Equality Day 2022 with an art exhibit at The Gallery Shop in Oakland August 24-31 plus a special event on Friday, August 26, joining national recognition of Women's Equality Day. The celebration this year was coordinated by the AAUW-Garrett Branch, the Garrett County Commission for Women, and the Garrett County Democratic Women of the GC Democratic Club. It was part of a statewide celebration of this nationally recognized event.

Last year's theme, "Hard Won...Not Done," focused on the "Hard Won" fight for women's suffrage. This year's Celebration continued the theme, emphasizing that realizing and enshrining gender equality is "Not Done."

The local celebration began Wednesday, August 24, with the opening of a special exhibit at the Garrett County Arts Council's The Gallery Shop, located at 108 S. 2<sup>nd</sup> Street, Oakland, MD. The art exhibit was developed by celebration partner VoteEquality who describes the vision of the art exhibit in this way: "Through partnerships with well-known artists, this project depicts diverse groups and communities, including LGBTQIA+, Black women, women of color, Indigenous peoples, and young people, to help them see themselves in the struggle

for equal rights in the Constitution. The art created for the project will financially support VoteEquality's work to ensure gender equality is part of our Constitution through online and live releases of limited edition, signed ERA art prints."

Says Judy Carbone, president of AAUW-Garrett Branch and chair of the coordinating committee, "The exhibit was first shown in Oakland, CA, and we are thrilled that it is now available in Oakland, MD. There is so much to learn about the continuing



effort to gain full gender equality. After the certification of the 19<sup>th</sup> Amendment in 1920, Alice Paul knew that the amendment wasn't sufficient to ensure full equality for women, so she wrote the original draft of the Equal Rights Amendment. It was first introduced in Congress in 1923. That was almost 100 years ago! 75% of Americans support the Equal Rights Amendment as part of our U.S. Constitution...almost as many of them (72%) believe that it already has been certified. It has not. And there are so many reasons why it should be. This exhibit celebrates gender equality guaranteed by the ERA and provides information on why it is necessary. There is still much work to be done to see that our children and grandchildren always have full gender equality."

A "Hard Won, Not Done" reception was held Friday on Women's Equality Day. During this event, which was free and open to everyone, there were opportunities to see and bid on the art, purchase raffle tickets for some of the posters and other items, food and beverages, information tables from the sponsoring organizations, and two panels of local women talking about their own experiences with gender equality and/or inequality. The first panel was composed of women students and the other of local women who are in the first part of their careers.

A poster unique to the Garrett County recognition of Women's Equality Day, designed by AAUW-Garrett Branch Vice-President Kendall Ludwig and her associate Olivia Weeks, both of CurlyRed. It was exhibited and raffled off, and copies are available for sale, the proceeds of which go to support AAUW-Garrett Branch.

Almost 100 people turned out for the "Hard Won, Not Done" Reception, and AAUW-Garrett Branch gained two new members. We were grateful that Tracy Lantz, AAUW-Maryland president, attended the event.

# **AAUW Maryland Fall Conference Registration**

#### October 15 AAUW-Maryland Fall Meeting Conference in Gaithersburg, Maryland

AAUW Gaithersburg is celebrating its 50<sup>th</sup> anniversary and looks forward to welcoming AAUW members from around the state. The venue is the Casey Community Center, 810 South Frederick Avenue (MD 355, also known as Rockville Pike along parts of its length), Gaithersburg, MD 20877. It is a Gaithersburg city landmark that you will recognize as a repurposed and renovated stone barn built in 1938.

#### Directions:

The Casey Community Center is located on the west side of MD 355. If coming north on MD 355 you will need to make a U-turn to enter the center driveway. Parking is free and located behind the barn. Signs will direct you to the entrance on the north side of the building.

# **Registration cost per participant: \$35 if reserved by October 5, \$40 if reserved after October 5, or \$15 if participating remotely via Zoom.** Fee includes morning coffee, refreshments, and lunch.

All attendees are required to be vaccinated. Masking will follow the local requirements at the time, although masks may be worn at any time.
