Inequalities in Health Care Affecting Women and Girls

Saturday, April 15, 2023 | 9 AM – 4 PM | Virtual and in Columbia, MD

Hosted by AAUW Howard County Branch

Convention Location: Howard County Community College, Duncan Hall, Kittleman Room, (Parking in **Lot A 10785 Little Patuxent Parkway**, Columbia, MD 21044). Connection via Zoom will also be available. The Convention is AAUW Maryland's Annual meeting and will include election of officers whose terms end June 30.

Program: The 2023 Convention will begin with half an hour of networking, coffee/tea, and snacks. The program will include presentations from two distinguished guest speakers from the healthcare field and a formal discussion. The topic of discussion during the morning session will focus on *Inequalities in Health Care Affecting Women and Girls: The "Fourth Trimester."* Health officials consider this a crucial period after the birth of a child. Unfortunately, the United States has a growing problem with providing adequate healthcare to women who have recently given birth. The rate of maternal death in the U.S. is nearly three times that of other developed countries. We will hear from experts in this field to understand the reasons behind this startling statistic and what can be done to improve healthcare and monitoring for new mothers. We are most pleased to tell you a little about our guest speakers:

Dr. Jameta Barlow, PhD, MPH, Assist. Professor of Writing at George Washington University



Dr. Barlow is a community health psychologist and an assistant professor of writing at The George Washington University in Washington, DC. Dr. Barlow utilizes decolonizing methodologies to disrupt intergenerational trauma, chronic health diseases, and structural policies adversely affecting Black girls' and women's health. Dr. Barlow holds a Bachelor of Arts in English from Spelman College, a Master of Public Health (MPH) in Maternal and Child Health from The George Washington University, and a PhD in Psychology from North Carolina State University.

Ms. Lee Taylor-Penn, MPA, MPH, Policy Director, Maternal Mental Health



Lee Taylor-Penn is a public health advocate passionate about promoting health equity through evidence-based policy-making, research, and community engagement. Before joining Maternal Mental Health Leadership Alliance (MMHLA), Lee was a Senior Policy Analyst at Families USA, where she provided policy analysis and strategy support with a focus on maternal health, health equity, and Medicaid. Ms. Taylor Penn has a Master of Public Administration (MPA) and an MPH from the University of Michigan-Ann Arbor, as well as a BA in liberal arts from the University of Mississippi.

Mini-Grants Available to Support Branch Projects as of July 1, 2023!

The 2022-23 Mini-Grant awarded to Anne Arundel County helped support the Artists4ERA event.

On January 28, 2023, the AAUW Maryland Board of Directors voted to allocate \$500 for the state Mini-Grant Program for the program year which begins July 1, 2023. This will be the Program's second year supporting public policy and/or diversity and inclusion projects.

Branches are able to use the funds to address a wide variety of issues, including, but not limited to: economic security for women and families (e.g., helping to close the gender pay gap and supporting paid family/medical leave actions); Title IX (e.g., eliminating campus sexual violence); access to health care; voting rights; human trafficking; diversity, equity and inclusion; promoting STEM studies/careers; seeking fair, non-partisan redistricting; salary negotiation skills (Smart Start and/or Work Smart); and ratification of the ERA.

Applications for the 2023-24 AAUW Maryland Public Policy/Diversity and Inclusion Mini-Grants are now available on our website at https://aauw-md.aauw.net/about/branch-mini-grants/. Details and the application are both there. It is under the tab "Tools for Leaders." A total of \$500 will be awarded this year. **The deadline for submitting applications is May 15.**

Public Policy Update

This is the busiest time of the year for AAUW Maryland public policy. The Maryland General Assembly is in session only 90 days: January 12 to April 10. We have eleven bills which we are supporting. On Valentine's Day, several of us were in Annapolis visiting the offices of Senate and House of Delegates committee members whose committees

were hearing our bills. We advocated for these four bills on our agenda that day, visiting around 14 offices in each chamber:

- End-of- Life Options Bill (HB 933, SB 845)
- Task Force for Emergency Room Wait Time Bill (HB274, SB387)
- Safe Harbor Bill for Child Victims of Human Trafficking (HB 297, SB292)
- Behavioral Care Modernization Act (SB101, HB48)

On Tuesday and Thursday, February 21 and 23, we gave live testimony for the ER Wait Time Bill. Maryland has had the worst ER wait time of all 50 states for the last 7 years.

On Wednesday, February 29, AAUW joined other groups in a rally outside the Supreme Court Building, in support of President Biden's student loan debt forgiveness program. That same day, the Supreme Court heard oral testimony for two cases regarding the legality of the program.

National. It is the hope of National to send out three notices to a member reminding them to renew. If they have not renewed by three months from their due date, they will be removed from the membership list. If you have further questions about the process, you can reach out to me.

Report of the Bylaws Committee

The Bylaws Committee has revised some of the Position Descriptions and some articles regarding state meetings in the AAUW Maryland Handbook. They pertain especially to treasurer's responsibilities.

A quick explanation about the Handbook – We refer to it as "the Bylaws," but it contains much more than that. In fact, it has six sections. The first is indeed the bylaws for AAUW Maryland. The following sections contain such material as AAUW's mission statement, history of the state organization, position descriptions for state officers, and a schedule and advice for preparing for a successful conference or annual meeting.

Noteworthy advice in the revised articles:

- When a member registers for a state meeting by writing a check, the check is made payable to **AAUW** Maryland, not to the host branch, and is submitted to the state Treasurer.
- 2. Income and expenses related to organizing a meeting are managed through the state Treasurer, not the branch or an individual member.
- 3. When a new state President or Treasurer is elected, the first step in transferring materials from the outgoing Treasurer to the new one is to go to the bank and change the signatures on the account. Typically, two people have authority to sign checks the Treasurer and the President. After the new officer has signature authority, then the checkbook and other records must be transferred.
- 4. Fundraisers at a state meeting: the Chair of the committee or a committee member must keep an accurate record of money received. For an auction (silent or live), create a list of items donated for the auction, the donor, and the amount of money raised by that item. This record, along with the funds raised, must be given to the Treasurer. Careful record-keeping is a protection in case the books are audited.

The goal of these revisions is to comply with Best Practices for an organization such as ours. You are welcome to submit other pieces of advice that are helpful to Diane Roca of Howard County, AAUW Maryland Bylaws Chair, dbroca@comcast.net.

Artists4ERA Event a Success!

The week-long Artists4ERA exhibit and March 4 reception at the Baltimore County Arts Guild Clubhouse in Catonsville, MD highlighted the continuing need to add the

Equal Rights Amendment to the U.S. Constitution. Working with VoteEquality.us, a national organization whose mission is to advocate for the ERA to be certified by the National Archivist, AAUW MD and three local branches along with other community organizations hosted the event. The Arts Guild Clubhouse was a great venue, well suited to art exhibits, very welcoming, and with easy access for the community.

On March 4, speakers reviewed the history of and next steps for moving the ERA forward. The program also included two panel discussions on gender equality. The first featured female students of high school and college age and one recent college graduate. These panelists spoke about challenges they faced due to their

gender, as well as their achievements leading and serving in socially active groups. The second panel consisted of three professional women who shared how they overcame career experiences dealing with sexual harassment, unequal pay, and discrimination.

The reception included of a silent auction of 14 posters created by various artists as well as a raffle for the chance to win an original art piece by San Francisco artist Chuck Sperry. Despite the wet and rainy evening, over 130 people attended. The silent auction raised \$1,800, and the raffle generated over \$800, with total donations to Vote Equality of over \$3,300.


