Dear Ms. Reichardt,

Thank you for contacting me to express your support for comprehensive and equitable Title IX rules. I appreciate hearing from you and apologize for the delayed response.

I agree that our schools must be safe environments for all students. Title IX is an important civil rights law to protect students from discrimination on the basis of sex or gender. As you may already know, there have been many recent changes to the Department of Education's (ED) rules related to Title IX. During the Trump administration, then-Secretary DeVos issued a Title IX final rule that weakened important protections for survivors of sexual assault and harassment. I joined my colleagues in writing to ED in strong opposition to this rule.

That is why I was pleased to see ED issue a new final rule in April 2024 that restores and strengthens protections for survivors and other victims of gender-based discrimination. In addition, these final regulations strengthen protections against discrimination for pregnant students, prohibit discrimination against LGBTQ+ students, and require schools to communicate their non-discrimination polices to all students and employees. I will oppose legislation that would repeal or weaken these rules, including resolutions under the Congressional Review Act like S.J. Res. 96.

As you may already know, the new Title IX final rule has been subject to a complex array of legal challenges since it was introduced, including seven separate lawsuits from various groupings of twenty-six states. Multiple federal courts have ruled in favor of these states, finding, among other conclusions, that ED overstepped its authority. In August 2024, the Supreme Court declined to overturn several of these orders, ensuring that provisions of the new rule would be blocked in all twenty-six states which have brought forward legal challenges. In addition, a Kansas federal judge ruled in favor of an additional suit brought by a group of states and private organizations, blocking enforcement of the new rule at hundreds of colleges across all 50 states. As a consequence, the new Title IX rule is only being enforced in a patchwork manner in the states and individual colleges where no court ruling has blocked its implementation.

Please know that I am monitoring these ongoing legal cases and will continue to fight to ensure that the rights of survivors and LGBTQ+ students are protected. Again, thank you for sharing your thoughts, and please do not hesitate to contact me whenever I may be of service.
