President's Message

Fall mtg

I think everyone in attendance will agree that the Fall Meeting hosted by the Anne Arundel branch was incredibly educational. We explored a topic that is not often discussed as part of the diversity, inclusion and equity sphere. Once we overcame the technical challenges, our three speakers enlightened us about the history of native women in the Maryland area, how tribes have created their own systems to educate their population, as well as

very serious issues faced by indigenous women across the country. We are hoping to have the video of the presentations available on the website at some point soon.

U.S. Department of Education Updates

The current administration's attempted destruction of the DOE is a primary focus for AAUW National. This week, there is *somewhat* positive news: the DOE has recalled approximately 200 laid off staff members from the Office of Civil Rights to help with the increasing backlog of civil rights complaints from students and families. I know that Meghan Kissel, AAUW's Public Policy leader, has mentioned that not addressing the civil rights complaints is one of the most egregious acts of the administration.

Maryland Matters reported on December 8, "In order for OCR to pursue its mission with all available resources, *all* those individuals currently being compensated by the Department need to meet their employee performance expectations and contribute to the enforcement of existing civil rights complaints," the email to the staff noted.

On the other hand, the department spokesperson also said, "The Department will continue to appeal the persistent and unceasing litigation disputes concerning the Reductions in Force, but in the meantime, it will utilize all employees currently being compensated by American taxpayers," So, we should be aware of any new efforts that AAUW develops to combat the efforts to dismantle the Department of Education. The bottom line is that we must continue to keep an eye on what is happening at the Department of Education.

Public Policy

Our state Public Policy (PP) committee got kicked off in November with introductions to new members, a survey to determine each person's state representatives, and discussion about the MLAW proposals for next year's General Assembly. We will have submitted our votes for the bills by the time this newsletter gets out, so thank you for your participation.

The PP committee includes the public policy representatives from each branch and branch presidents. However, other interested members are welcome to join and participate in our meetings, bill tracking and lobby day. Please contact me to be added to the PP committee email list.

Upcoming key dates for Public Policy are:

- January 14: Maryland General Assembly convenes - Annapolis
- January 31: Women's Legislative Briefing – Universities at Shady Grove, Rockville
- February: MLAW's Legislative Briefing (date TBD)
- February/March: MD AAUW Lobby Day (date TBD)

In addition to our state advocacy efforts, please continue to respond to the Action Alerts from National. One alert came in today for another Civil Rights problem, this time at the Department of Justice. And I will mention again that all members are strongly encouraged to join the Capitol Hill Lobby Corp.

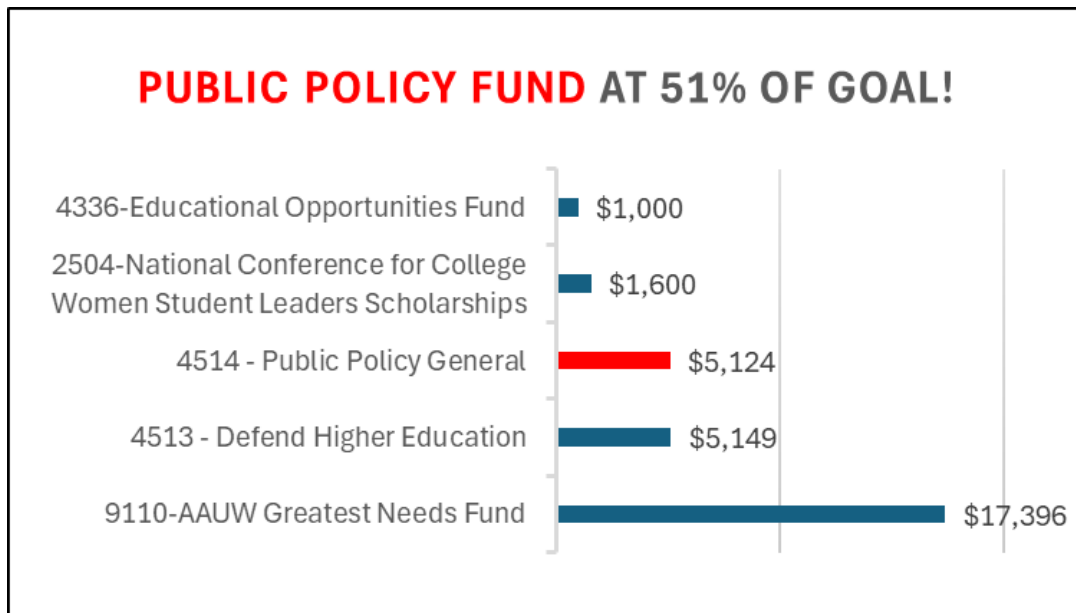

As of April 1, 2026, there will be a \$2.00 increase in AAUW national dues moving from \$74 to \$76 for the upcoming fiscal year. The good news though is that the Shape the Future Campaign still gives a 50% discount for new members or for those who rejoin after a two-year absence from AAUW. In addition, all \$76 remains tax deductible, just as in the previous year. As you've likely heard, the 2026 AAUW Regional Conference Unfinished Revolution: Together We Stand, is being planned for **September 25-27 in Lancaster, Pennsylvania**. Please plan to join your friends and AAUW colleagues from 13 states at the [Lancaster County Convention Center & Marriott Hotel in Lancaster, PA](#).

I've just received the details regarding the conference registration fee! Early bird registration is \$249 until July 19, 2026, and \$295 thereafter. Here's the conference link: <https://www.aauwatlanticregionalconference.net/>

Be sure to make your room reservation as soon as possible! The special discounted rate is available before Tuesday, August 25, 2026; Friday, September 25, 2026 to Sunday 27, 2026, 2026 at \$225 per night plus taxes with a 2-night minimum. Be sure to indicate that there will be two adults in your room if you plan to have a roommate. This will assure that you are assigned a room with two beds. But trust me, the room block will be full before August! Of the block there are only about 50 rooms remaining. These will fill up fast! If you are planning to attend, please make your reservation as soon as possible. You don't want to miss out on the fun! Parking is an additional fee of \$15 per day. Your room reservation may be cancelled up until the week of the event.

We've secured an amazing group of speakers on current topics of interest to women in the Atlantic region as well as individuals who will address the [AAUW Policies for 2025-2027](#): Education, Economic Security, and Social Justice and Civil Rights. Our own Kate Campell-Stevenson of the Kensington Rockville Branch will perform her one woman show on Friday evening, September 25th. We are also excited to confirm that Dr. Susie Mosser of the Garrett Branch will be one of our presenters! Stay tuned for more details on the program.

The location of our conference, Lancaster, Pennsylvania is a wonderful city and one of America's oldest inland cities to date. It served as Pennsylvania's capital from 1799 to 1812. 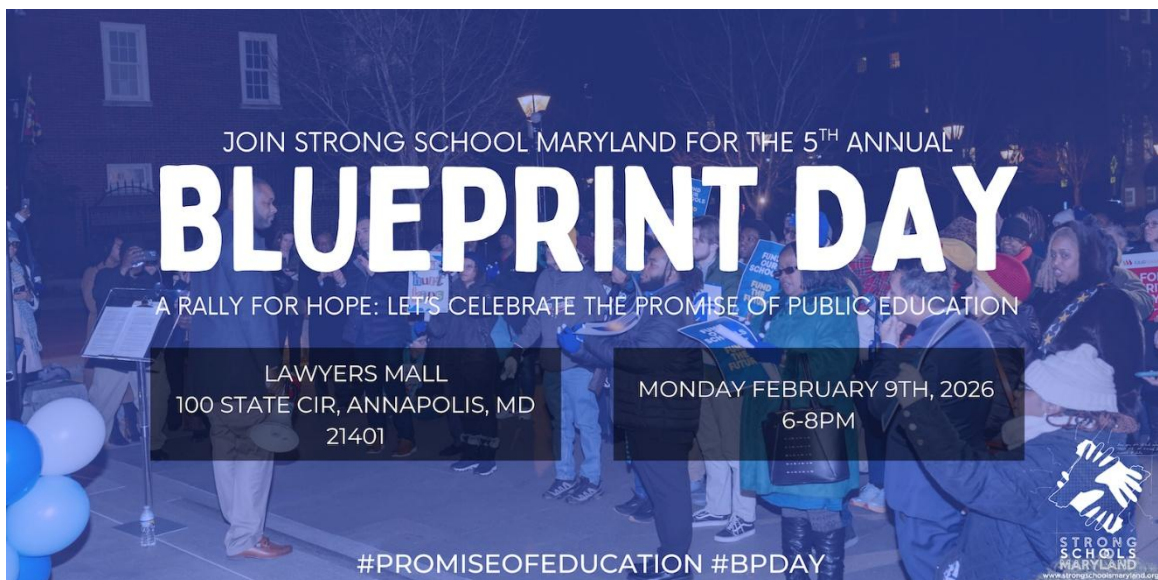
Anne Arundel County Branch News
